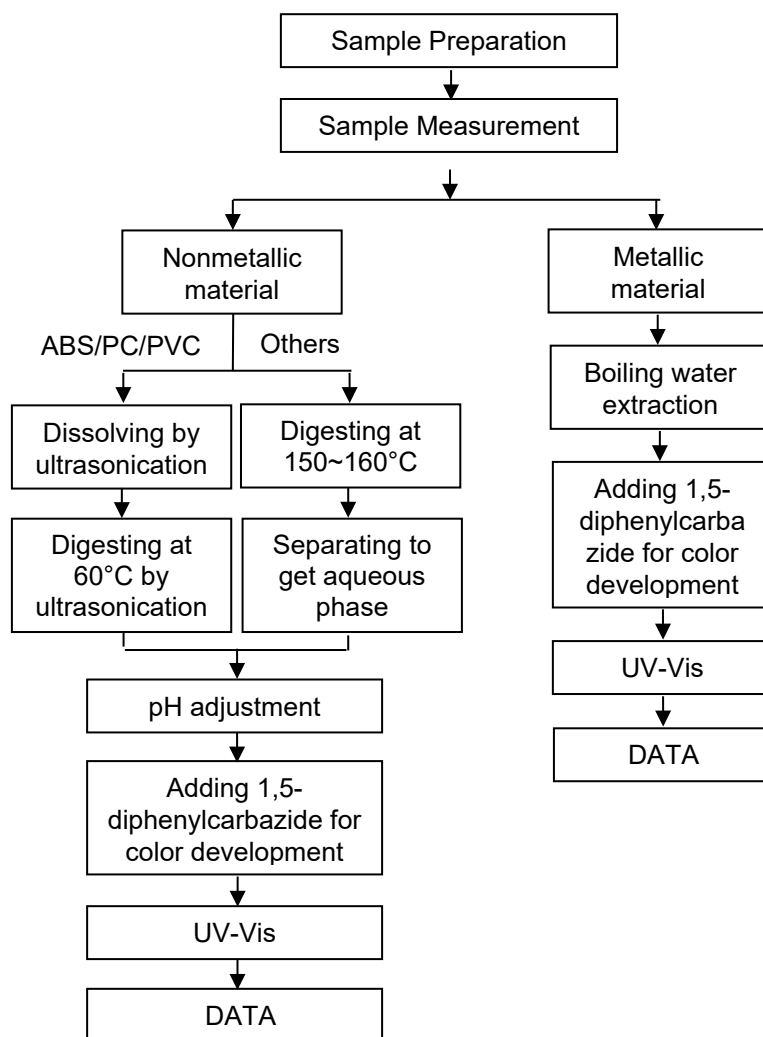

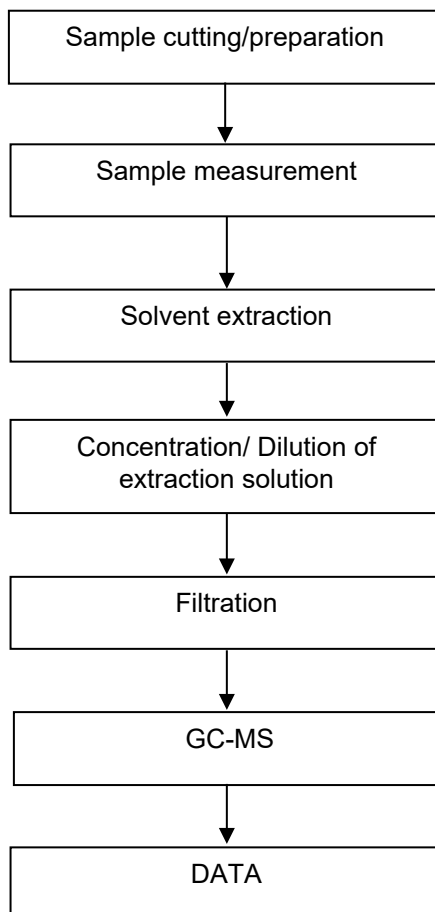

Phthalates Testing Flow Chart



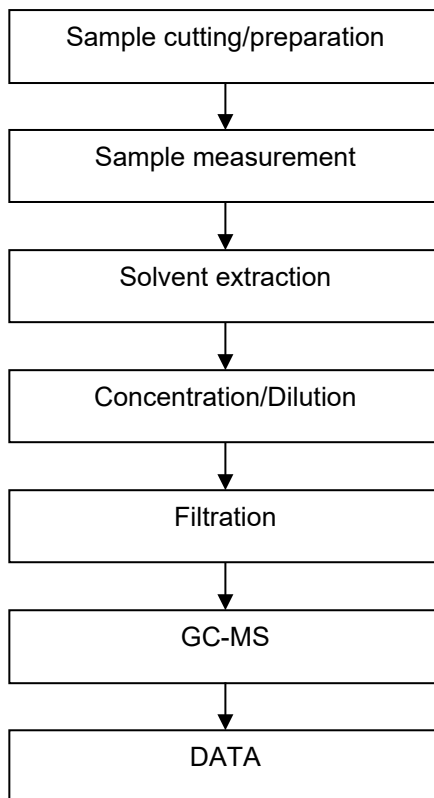

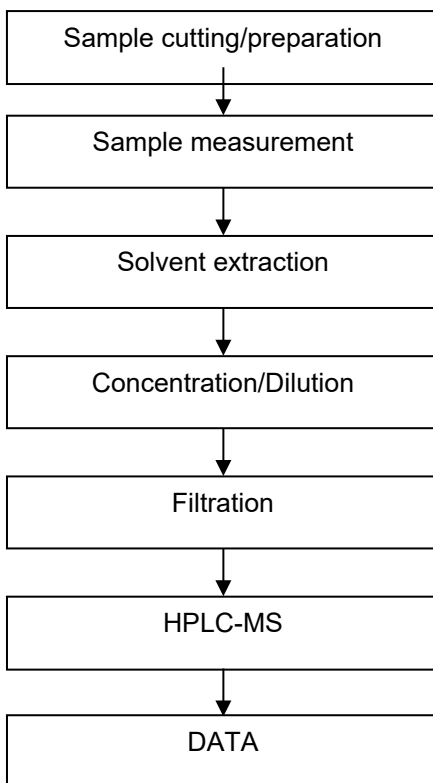

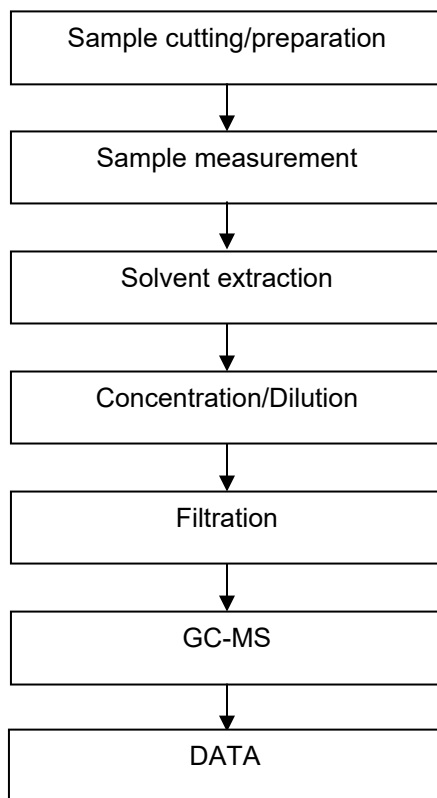

Organotin Testing Flow Chart



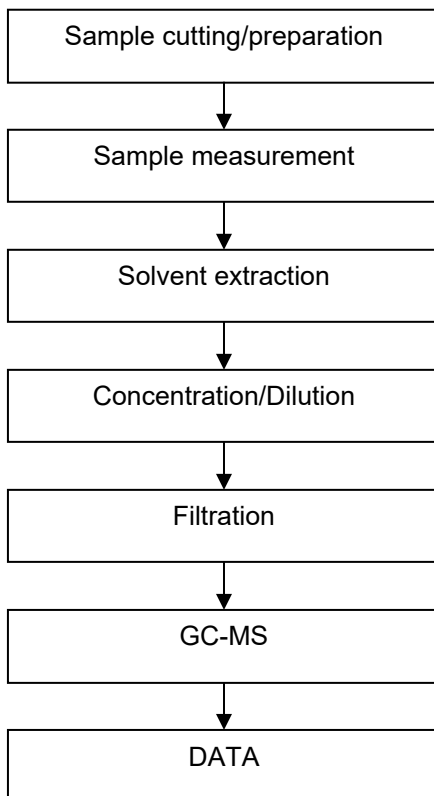

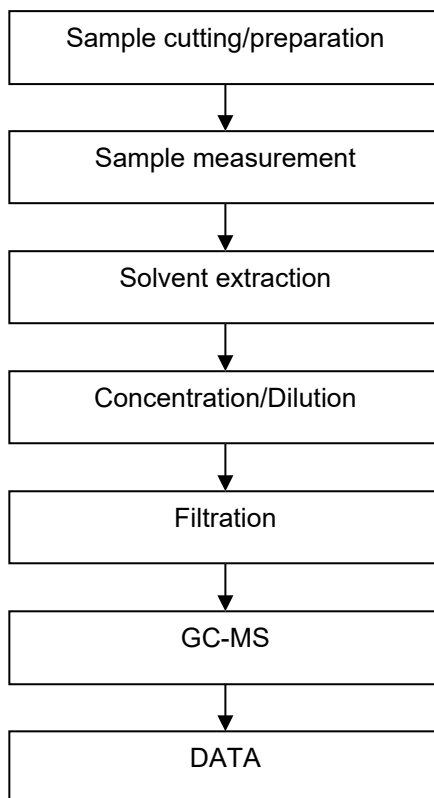

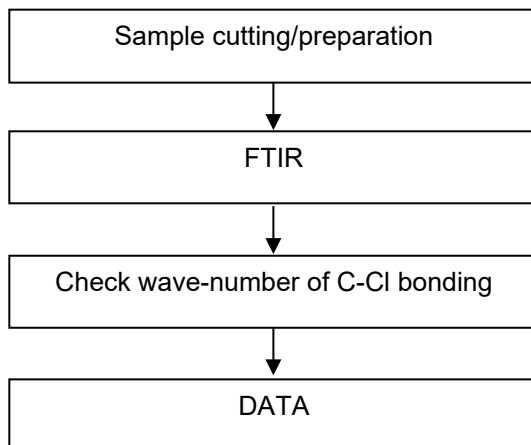

PVC Testing Flow Chart



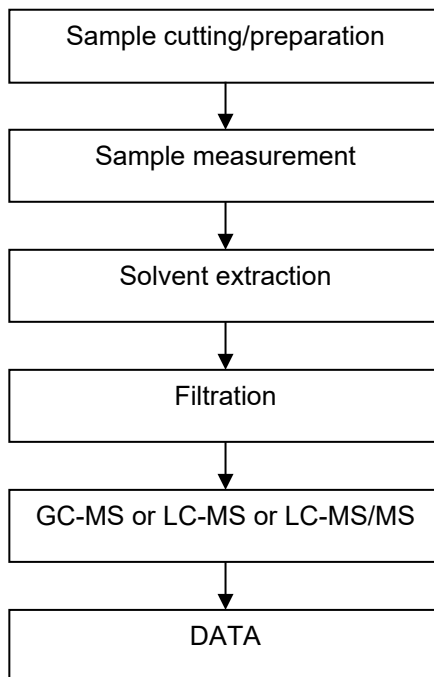

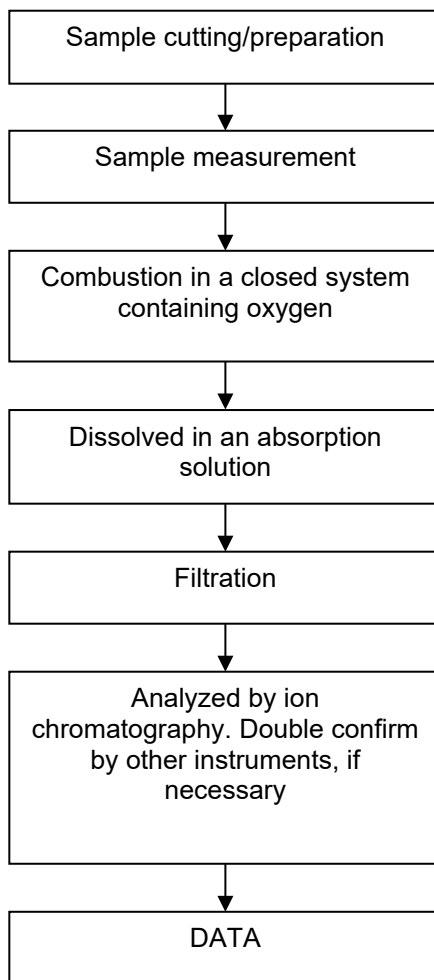

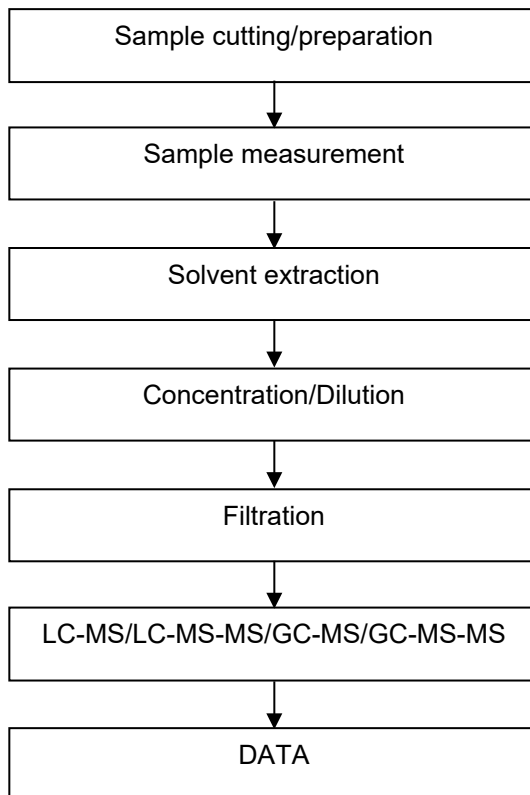
TBBP-A Testing Flow Chart

PFASs/ PFOS/PFOA Testing Flow Chart



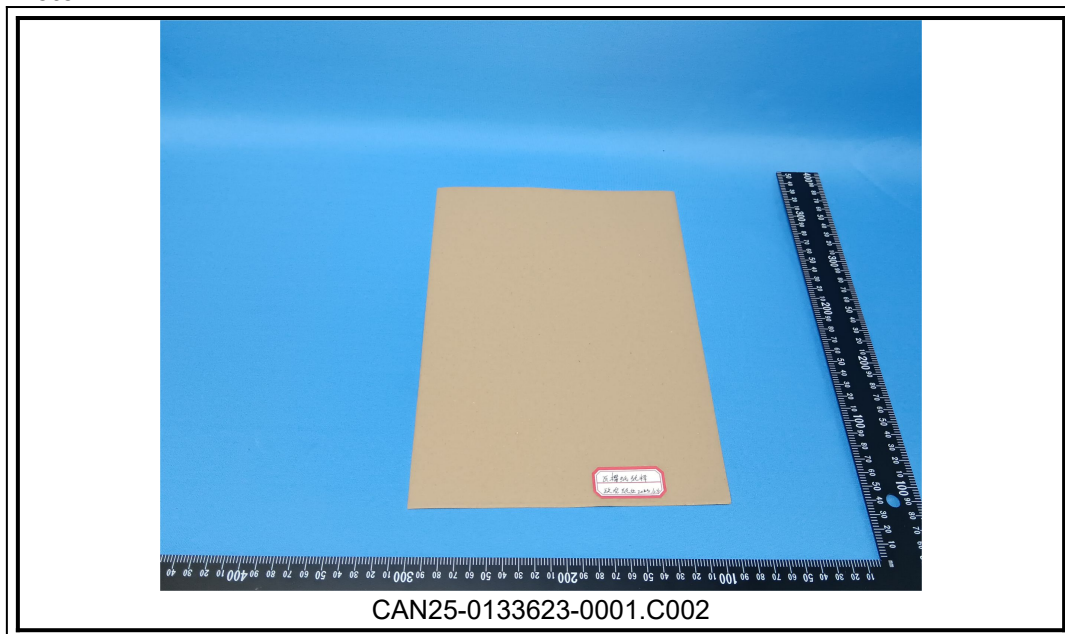
